1.0 Reference: Te Rangatira Te Tangata Whenua, Rhys Richard Ngahiwi Warren
(hereinafter referred to as the Detainee).

2.0 Sentenced to life imprisonment with Preventative Detention.

3.0 I hereby confirm the support of He Wakameninga O Nga Rangatira O Nga Hapu (Confederation of Sovereign Hereditary Chiefs for the Detainee).

4.0 I also confirm the desire of the Detainee to withdraw from the Appeal Court process.

5.0 The Detainee has lost all confidence, and semblance of reliance on the current court system, to mete out Justice.

6.0 This lack of reliance on the court system has been exacerbated by Mr. Ewen, the Appeal Court appointed lawyer.

7.0 Mr. Ewen has inferred, or purports to have inferred, that the Detainee is mentally unstable.

8.0 The entire case from the onset, when the purported offence happened to the current date, has been a litany of lies, deceit and fraud by the entire Policing System, the Justice System, the Prison System and now the Appeal Court System.

9.0 Our intention is to highlight and speak to the issues.

10.0. The Detainee is exercising a right to seek justice in the Court of Human Rights in Strasbourg, France.

11.0. In exercising his right as a Rangatira, (Dejure) the Detainee has sort help from He Wakameninga O Nga Rangatira O Nga Hapu.

12.0 He Wakameninga O Nga Rangatira O Nga Hapu have convened an emergency sitting of **Te Kooti Teitei Maori**.

13.0 **Te Kooti Teitei Maori** (The Highest Court in the Land) has ruled in favour of the Detainee.

14.0 This ruling state that the entire case pertaining to the Detainee is flawed and is a travesty of justice.

15.0 **Te Kooti Teitei Maori** has also recommended, that the Detainee make submission to the Court of Human Rights to seek Justice and fair and comprehensive remedy.

16.0 **Te Kooti Teitei Maori** have ruled that the State, that is the for-profit Corporation Her Majesty the Queen in Right of NZ, the Crown in Right of NZ, the Sovereign in Right of NZ, the Arms in Right of NZ, the Monarch in Right of NZ and all its Parasital organisations set up to form different functions of State, have perpetrated a fraud against the Detainee.

17.0 At the time the alleged offences were purportedly committed the Detainee was asleep in his family home.

18.0 What transpired was the police began to concoct a narrative that the Detainee on three or four occasions over a period of hours, fired a shot gun at a police aircraft overhead.

19.0 No person was seen coming out of the house, no photograph (of which there were many) could identify a person coming out of the house.

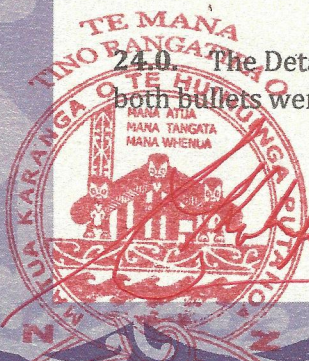
20.0 The only thing the police had to go by was an onsite police officer who claim he saw a puff of smoke after he heard a shot gun being fired and heard a door slam.

21.0 This set off a chain of events whereby the Armed Offenders Squad (OAS) was called out.

22.0 The Armed Offenders Squad (OAS) were given a **F061 SHOOT TO KILL order**.

23.0 Police went into the house empowered by the F061 order and they opened fire shooting 46 rounds inside the house.

24.0 The Detainee managed to get a firearm and fired two warning shots of which both bullets were accounted for.

25.0 It is the considered opinion of **Te Kooti Teitei Maori** that three officers inside the house were shot by friendly fire.

26.0 It would also appear that the officer outside the house was also shot by friendly fire.

27.0 With three officers down inside the house, police had to evacuate their people.

28.0 Upon vacating the house, the police claim to have left a pistol inside the house.

29.0 The police claim that the Detainee fired two shots from the police pistol which maimed a fourth officer outside in the cordon.

30.0 Upon perusal of the evidence and in particular the police list of exhibits, it shows the pistol was recovered.

31.0 "The list of exhibits" also shows that the magazine for the pistol was also recovered and the magazine was FULL.

32.0 This means the gun was not fired.

33.0 It also means the officer hurt outside the house **WAS NOT** shot by the Detainee.

34.0 The independent police complaint authority report was scathing on the police conduct tactical errors and overall miss management of the entire incident.

35.0 The police perpetrated a fraud on the Detainee by concocting a litany of lies.

36.0 The police also need to be made accountable for the police officers who were shot.

37.0 The court that rubber stamped the fraud by the police must also be seriously reprimanded.

38.0 The judge that committed the Detainee to Life Imprisonment with Preventative Detention must also take responsibility for endeavouring to cover up the fraud.

39.0 By passing down such a harsh sentence, it would appear to be an act of locking the Detainee away, so that the story never sees the light of day.

40.0 Hence, He Wakameninga O Nga Rangatira O Nga Hapu support the Detainee to withdraw his appeal from the system.

41.0 He Wakameninga O Nga Rangatira O Nga Hapu also recommends that the Detainee totally disengages from the state for-profit Corporation who are masquerading as a government.
